| 4. | Minutes It was resolved that the draft minutes of the Parish Council Meeting held on 14/7/16 and the 2 planning meetings held on 11/7/16 were a true and correct record of the meetings. The header on the minutes from the planning meeting held on 16/7/16 was amended to read Kingswood Farm. These minutes were then approved as a correct record | |
| 5. | Matters Arising from the minutes GT raised the issue of the state of the slipway to the church. TV reported that the greenery had been cleared. Resolved to monitor situation and JS to investigate if the path is a registered footpath | JS |
| 6. | County Councillor Report There was no County Councillor present to report. District Council Report A Trollope-Bellew reported that WSDC had yesterday voted to form a new council with Taunton Deane, to take effect in May 2019. This still has to be approved by the Secretary of State and then the Boundary Commission will become engaged to divide the area into new wards. The projected savings of merging the two Councils is £500,000 per year. When asked about the future of the Williton offices of WSDC, AT-B was hopeful that they would be maintained for some services AT-B had no more news on the development of Hinkley Point C | |
| 7. | Police Report A police report was emailed to the clerk prior to the meeting: Crime figures for the whole of the Williton/Watchet beat area RECORDED CRIME – AUGUST TO AUGUST 2015 /2016 Criminal damage, down 29% Fraud and Forgery, down 100% Other Offences (unspecified) up 125% Racially or religiously aggravated crimes, nil % (3 each year) Shoplifting, up 60% Theft of Motor vehicle, up 83% In most cases, the numbers used to calculate the % are very low-for examples total reported crimes year on year is 500 vs 573 Violence against the person, up 53.9% (this is probably due to a different way of recording crimes year on year) | |

TOTAL CRIMES, up 14.% FULLY RESOLVED CRIME RATE, down 6.4%
 Many crimes are not recorded as they are not reported correctly - PLEASE report incidents via the 101 or 999 route, not by word of mouth via 3rd party as information gets lost or confused
 A noticeably higher level of Policing may well be apparent at the moment. DO NOT BE ALARMED. This is due to an influx of Police Officers patrolling rural and farming areas to ensure a highly visible presence for a period of time during a specific Operation. Your local Officers, both Response and Neighbourhood, will patrol as normal

8. Neighbourhood Plan Update

The chairman reported that the required documents had been submitted and it had been raised that a Strategic Environmental Assessment may be required regarding the car park in Beacon Field. This would be financially beyond SPC and the car park has already been granted permission to be built so is not relevant to the NP. Awaiting advice but it was considered that it may be better to remove mention of the car park from the NP if the consultancy don't agree that a SEA is not needed?

JS felt it was wrong that a consultant agency could be in a position to recommend the need for a report that will bring income to that same agency
 JS also reported that it will probably be necessary to change the wording in the NP to reflect future parking needs – adequate car parking must be provided with any proposed developments. JS
 Any re-wording within the NP will have to come back to SPC for approval.

9. Playground

a) Update on Adoption Process

Magna are not happy with Charity Commissions advice that the playground association be fully wound up (which could take a couple of weeks) before a new lease is granted to SPC as this would leave them with the liability for a period of time. JS to ask Charity Commission why they recommended this course of action JS

b) Repairs

An additional load of woodchip has been delivered and spread under play equipment
 Councillors agreed to meet at the playground the next Tuesday evening to inspect the equipment and discuss what further repairs were required JS & CB

11. The Beacon Field

a) Discuss Quotes for Car Park

TV confirmed that Criddle's still have not yet converted their estimate to a definitive quote. TV to chase Criddle's. If no quote forthcoming, then other the contractors that were requested to provide costings will have to be approached TV

SPC is unable to proceed with grant applications until a firm quote is received.
